- Energy and Environment committee

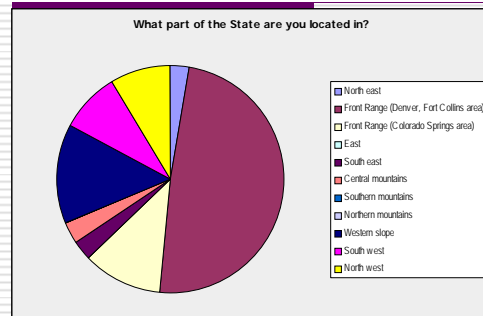

- Web survey, email list distribution

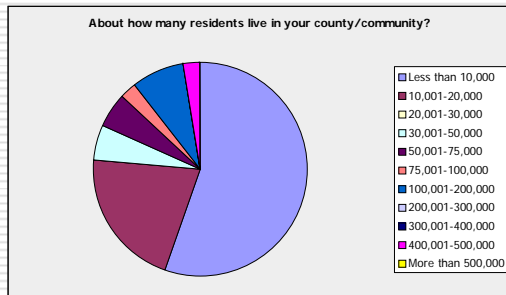

REGIONS OF STATE REPRESENTED



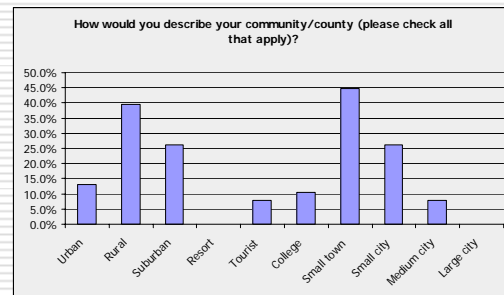

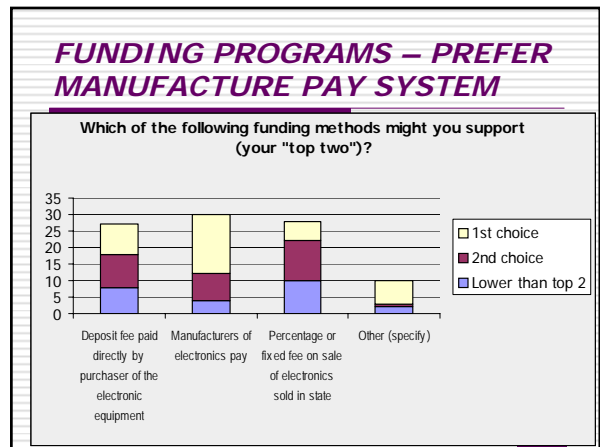

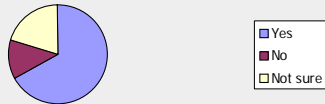

IN FAVOR OF HEALTH / SAFETY / SUSTAINABLE PRACTICES REQUIREMENTS

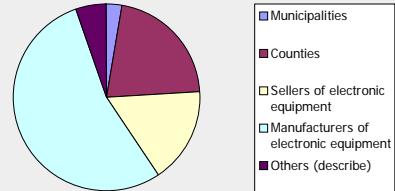

PREFERRED PROGRAM DELIVERER - MANUFACTURERS

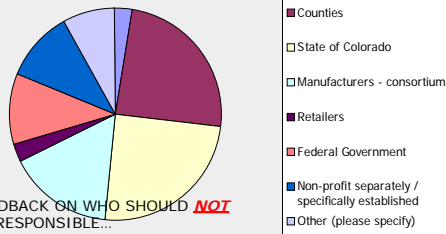
Who should be responsible for delivering the electronics recycling program?

Who should be responsible for administration / oversight of the program?

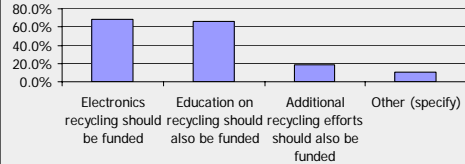


FEEDBACK ON WHO SHOULD NOT BE RESPONSIBLE...

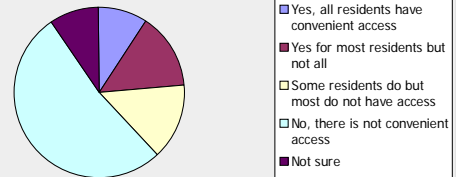
RURAL CONCERNS / CONSIDERATIONS

- About 60% say they are rural
- 1/2 willing to help depending on cost; 2/3 willing to help...
- Sufficient access is 2-3 sites per county -
 - Mail-in only NOT considered sufficient by any

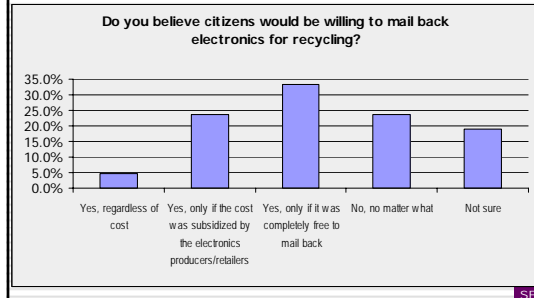
RURAL AREAS DO NOT FEEL THEY HAVE CONVENIENT ACCESS

- Big picture
 - Why recycle E-waste?
 - What is working / not
 - How to get there
 - Voluntary or markets / mandatory or legislation
- Responsibility and Funding
 - Options

SUMMARY

- Communities vs. county / manufacturer responsibility
 - Infrastructure more commonly county or private
- Medium priority on radar screen
- Status quo
 - Events (1/2), some stores, 1/3 sites in town
- Preferences:
 - Education and manufacture programs (followed by disposal ban)
 - Prefer manufacturer supported system
 - Delivered by manufacturers or counties
 - Oversight by county or state (or mfg consortium)
 - Education should also be funded

SUMMARY

- Rural issues – 2/3 rural; 1/2 say no convenient access; 1/4 say “some” have access
 - Mailback system may be acceptable – if free or subsidized
 - 1/2 or towns willing to help facilitate systems in rural areas, depending on cost
 - Convenience needs 2-3 sites per county
- Unfunded mandates - Deposits preferred (explore others also?)
